PRIVACY POLICY Dallas Builders Association

Protecting your private information is our priority. This Statement of Privacy applies to the Dallas Builders Association managed websites and governs data collection and usage. By using the Dallas Builders Association websites, you consent to the data practices described in this statement.

**Collection of Your Personal Information:** To better provide you with products and services offered on our sites, the Dallas Builders Association websites may collect personally identifiable information, such as your:

We also may gather additional personal or non-personal information in the future.

#### **Use of your Personal Information**

### **Sharing Information with Third Parties**

### **Automatically Collected Information**

Information about your computer hardware and software is not automatically collected by the Dallas Builders Association.

#### Use of Cookies

Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.
