Association addresses thorny electrical code provision, pool proximity

By Phil Crone Executive Officer A new requirement in the 2020 National Electric Code, effective statewide in the fall, and now being adopted locally by several cities, has a signifi-

cant flaw. Specifically, Section 210.8(F) requires GFCI protection for air conditioning and heat pump equipment. Normal operation of this equipment, within UL standards, can trip the GFCI device rendering the equipment inoperable.

This poses an obvious health and safety risk to homeowners in the coming summer months. The problem has begun to manifest in the Houston area and will likely do the same here when summer eventually arrives.

Fortunately, the National Association of Home Builders, Leading Builders of America and the Texas Association of Builders have responded quickly as have state regulators.

Following an emergency meeting on May 18, the Texas Department of Licensing and Regulation voted unanimously to suspend enforcement of Section 210.8(F) until Jan. 1, 2023. Per the commission's rules, the emergency order must be renewed every 120 days. We expect it will be until the commission enacts a permanent rule delaying enforcement until 2023.

Association staff are in touch with the building officials who comprise the leadership of the Regional Codes Coordinating Committee through the Council of Governments (RCCC).

We expect the set of 2021 regional amendments to follow TDLR. We are also reaching out specifically to cities that have or soon will adopt the 2020 NEC.

If electricians are installing GFCI protection per this provision, builders are likely to experience challenges in those communities. Therefore, we urge you to make your team aware of this issue and the state's delayed enforcement that became effective on May 20.

Another note on codes. A number of builders have expressed concerns with homeowners installing pools, post construction, in close proximity to the foundation leading to warranty calls and possible failures.

In response, the Dallas BA is working with the RCCC to add a new provision to the regionally-adopted International Pool and Spa Code. Specifically, swimming pool depth shall maintain a 1:1 ratio from the nearest building foundation or retaining wall, meaning that the edge of a 5-foot deep pool must be at least 5 feet away from the foundation. Installations closer than this ratio require a sealed engineered drawing.

This amendment was modeled off of existing policies in several cities. We feel it is a good starting point to ensure the issue is considered in several area jurisdictions.

Dallas BA Takes Lumber, Workforce Energy Code, Other Concerns to Congress

Dallas Builders Association members and staff met with our service area's U.S. Congressional delegation during the first week of May to engage on key policies and challenges that impact home building.

The meetings were part of Dallas BA's participation in Bringing Housing Home, the annual legislative conference held nationwide in coordination with NAHB. The centerpiece of discussion was the crisis of soaring prices and delays being brought on by shortages in lumber and other building materials.

As some builders in the region have reported seeing lumber prices more than quadruple over the past year, the challenge to produce affordable housing also increases. Dallas BA explained to our members of Congress how lumber price spikes have caused the price of an average new single-family home to increase by what NAHB now estimates to be nearly \$36,000 since mid- April 2020.

Dallas BA urged our members of Congress to push the White House to undertake a thorough examination of the lumber supply chain and seek remedies that will increase production, as well as return to the negotiating table to seek a new softwood lumber agreement with Canada.

This year's legislative conference proved timely as, that same week, U.S. Secretary of Commerce Gina Raimondo appeared before a House Appropriations subcommittee. During the hearing, multiple members of Congress raised the concern about rising lumber prices and production issues.

This was followed by the Biden Administration facing questions about the lumber issue again the next week, as U.S Trade Representative Katherine Tai heard concerns raised by multiple Senators during a hearing of the Senate Finance Committee.

In both hearings, Representatives and Senators cited how they had heard about the issue from home builders. On May 12, U.S. Senators Jeanne Shaheen (D- N.H.) and Jerry Moran (R - KS) even sent a letter to Secretary Raimondo and Trade Representative Tai stating that, while the December 2020 reduction of tariffs, by the previous Administration, for some producers of lumber from Canada was a step in the right direction, complete elimination of the tariffs is necessary for the relief in rising lumber prices.

While the message about the need

to address lumber production and reduce tariffs was clear, continued follow up will be needed as it is unclear as to what direction the Biden Administration intends to move.

In the week following their telling Congress that they will make lumber a priority, the Administration sent a troubling signal. On May 21, the Commerce Department announced it is seeking to double tariffs via the preliminary determination for new rates on Canadian softwood lumber. The proposed rates are subject to review over the next six months until the duties become final.

Lumber was not the only policy item discussed with our members of Congress.

Dallas BA also stressed the importance of ensuring that any energy codes recommended by federal agencies bring real benefits that can be repaid through utility savings in 10 years or less.

Advocating for an incentive approach, as opposed to handed down mandates that just add cost, Association members raised awareness to a tax credit that offers developers and builders a means to offset the costs associated with building energy efficient single-family and multifamily homes.

Commonly known as 45L tax credits, the International Revenue Code provision offers an offset against taxes owed or paid in the tax year in which the property is sold or leased. Construction is to be done by an eligible contractor and third-party analysis is required.

The provision was extended through 2021, when the Consolidated Appropriations Act was signed into law by President Trump in December of 2020 and will need further action to extend beyond this year. David Lehde Director of Government Affairs



With a possible infrastructure bill being widely talked about in Washington, Dallas BA members stressed the importance that any legislative package must consider housing affordability and avoid unneeded mandates on home construction.

A concern that arose during previous infrastructure bill discussions on the Hill is the idea of putting electric vehicle supply equipment into model building codes. Federal, state and local governments should avoid drafting any mandate for new homes to be "EV charging station ready." Dallas BA let our members of Congress know that it is unfair for home buyers to pay for mandates placed on home construction related to a vehicle that they may not even be able to afford.

The Association also pointed to provisions that could promote attainable housing while helping deliver infrastructure, including lowering costly impact fees, lessening strict zoning requirements and streamlining development processes.

Dallas BA also advocated for the need to ensure home building has a trained and adequate workforce, housing finance reform, the need to strengthen the low-income housing tax credit and the importance of seeking a lasting flood insurance solution.

Dallas BA thanks Representatives Colin Allred, Michael Burgess, Beth Van Duyne, Pat Fallon, Lance Gooden, Van Taylor and Marc Veasey for the opportunity to meet with them and their legislative staff. And we thank our membership for their participation in continued advocacy for sound housing policy at all levels of government.


